



**Booth College Gala Day
2017 Touch Football
Competition
Liability Waiver and Terms & Conditions**

(FOR CHILD PARTICIPANTS)

It is important that you read and consider the following Liability Waiver and Terms & Conditions.

Booth College will permit your child's participation in its Gala Day Touch Football Competition only if you have read and signed this Liability Waiver on your child's behalf.

- 1) For the purpose of the following document, Booth College means:
 - a) The Salvation Army (being the worldwide unincorporated religious and charitable association);
 - b) The Salvation Army (New South Wales) Property Trust;
 - c) The Salvation Army (Queensland) Property Trust;
 - d) Any organisations or bodies corporate owned or operated by any of the bodies mentioned above; and
 - e) Any employee, officer, volunteer, servant, contractor or agent of any of the bodies mentioned above.

- 2) I give consent for my child to participate and/or be a spectator in Booth College's 2017 Gala Day Touch Football Competition (referred to as 'the Competition'). I recognise that my child is undertaking the recreational activity of touch football for the purposes of enjoyment, relaxation and leisure. I accept there is a degree of physical risk to this recreational activity and in making the decision for my child to participate and/or spectate, I understand and I am aware of the risks arising from this activity, including but not limited to the following:

Collision injuries, fall injuries, head injuries including concussion, eye injuries, dislocations, muscle or ligament strain, muscle/ligament tear or rupture, bone fracture or bruising, respiratory or cardiac conditions and other injuries, impairments and/or disabilities. (collectively "Injuries")

- 3) I agree to assume the risk of any Injuries and any damages and/or loss that my child may sustain as a result of being a participant and/or spectator at the Competition. I declare that I have read and understood the risk warning above.

- 4) I understand that my child's participation and/or spectatorship in the Competition is entirely voluntary.

- 5) a) I hereby release and discharge Booth College from any and all current and future claims of loss, damage, or harm to property or persons including but not limited to my

child, made by me or any other persons as a result of my child's participation and/or spectatorship at the Competition; and

b) I agree to indemnify Booth College and keep it indemnified from all actions, suits, claims, demands, costs and other loss and/or liabilities of any nature by any third party, and against all injury, damages, loss, costs and expenses incurred by Booth College (including consequential or indirect), arising from or out of my child's participation and/or spectatorship at the Competition.

- 6) I warrant that my child does not have any medical, physical or psychological conditions that would be aggravated by or limit their participation and/or spectatorship at the Competition. I understand that if I cannot provide this assurance, I will give prior notice of my child's medical conditions to Booth College. Following this notification, I accept that Booth College will have sole discretion to allow, decline or limit my child's participation and/or spectatorship in the Competition.
- 7) I authorise Booth College to obtain such medical assistance and ambulance transportation for my child in the event of illness or injury as they think necessary and I authorise qualified medical practitioners to administer anesthetic, blood transfusions or any other procedures deemed necessary to my child. I agree to meet all medical expenses associated with such medical assistance or ambulance transportation.
- 8) I warrant that my child will be wearing footwear and clothing which is proper and safe for the recreational activity of touch football through their participation in the Competition.
